





## **Purpose**

To seek Pine Creel Local Authority identification and endorsement of a project to be delivered through Election Commitment funding and the required 50-50 cocontribution.

#### Recommendations

# **Key Issues**

At the February 2023 Pine Creek Local Authority (PCLA) meeting, the PCLA agreed through resolution PCLA-2023/7 to commit the required co-contribution of \$50,000 to accept the offer of an additional \$50,000 funding through Election Commitment funds. This means that the Pine Creek Local Authority now has \$100,000 ex GST to undertake project/s supporting playgrounds, BBQ's or public fitness stations.

# **Background**

In the 2022-23 financial year the NTG Cabinet committed to providing funding for a list of minor infrastructure projects across the Northern Territory to promote community well-being and social inclusion. As part of this commitment, Council was offered \$100,000 to contribute toward playgrounds, BBQ's and public fitness stations in the Pine Creek and Timber Creek communities (divided equally between the two communities). Under this arrangement a 50-50 funding co-contribution is required to claim the additional funds.

At the February 2023 Pine Creek Local Authority meeting, the Pine Creek Local Authority agreed through resolution PCLA-2023/7 to commit the required co-contribution of \$50,000 to accept the offer of the additional \$50,000 funding through election commitment funds.

This means that the Pine Creek Local Authority now has \$100,000 to undertake project/s supporting playgrounds, BBQ's or public fitness stations.
